ACT has developed several dual credit programs that gives students college credit that can be used at any West Virginia College. We also have several articulation agreements with Universities and Community Technical Colleges

The 8th Grade Career Exploration Leadership Academy creates an environment for students that introduces them to the world of career-technical education, fosters social-emotional well-being, and emphasizes the knowledge and skills necessary to be a successful student, and future member of the workforce. With a goal of providing these students with the tools necessary to reach graduation and beyond, we partnered with middle schools to identify atrisk students who would most benefit from the experience. Since first piloting the Academy in 2019-2020, we have seen positive results. Several students from the initial group of have now enrolled at ACT having successfully met requirements and have stayed on track to graduate.

ACT maintains and creates community engagement and involvement opportunities through numerous events and initiatives. These include advisory councils, a social media presence, a newsletter, and our long-standing tradition, the Festival of Trees. 2nd year of a new event, Tech-or-Treat which drew in over 1000 people to the school last year. We continue to pursue and implement new ways to open the doors to our school and the world of CTE.
