Once Financial Aid Applications Are Received by ACT

BE ADVISED FAFSA applications take up to 10 business days to be processed by the Department of Education.

- If needed, you must supply any required documentation to verify your financial aid application.
- Complete the Board of Cosmetology application and Certificate of Health form that can be found on our website.
- o Schedule an appointment with Melani Hylton to register for class.

- Sign a cost sheet and agree to all school policies.
- o If applicable, sign a financial aid award letter.
